Treasurer's Report: We currently have a balance of \$3,835 in checking. This represents no change in the cash flow. Christi Guillmen moved and Rod Byler seconded the approval of the treasury report.

OSUAA Scholarships: The Scholarship interviews went well. There were 37 applicants from all public schools in the County and Carroll. Six of them were #1 in their class. 80% were in top 10% of their class. The students were interested in majoring in Social Work, Int'l Studies, History, Engineering, Business, Law and Optometry. Our goal is to award 11 scholarships. Our selections have been forwarded to Ohio State along with some alternates. OSU will tell the students they have won a scholarship before we know. There were several conflicts in having the students interview on one Saturday. Will discuss alternatives for next year.

Scholarship banquet: Ohio State has an approved list of speakers and the one we requested wasn't on it. The Club will look through the available speakers and request one. Dates are still May 5, 7, 12 or 14.

Campus Tour Ideas: We are set up with the Vet School for a tour in May. Will have lunch somewhere and then tour the Woody Hayes facility.

President's Club: We are still trying to get a separate organization controlled by the Club to collect \$ for scholarships. It must be a tax-exempt organization.
